JFS VOLUNTEERS PICK UP FOOD DONATED BY WAWA AND VARIOUS OTHER GROCERY STORES ALONG WITH FRESH FOOD DURING THE SUMMER FROM MONOCACY FARM. THESE DONATIONS PROVIDE EXTRA SPECIAL FOOD FOR OUR PANTRY RECIPIENTS. JFS ALSO COLLECTS CHILDREN'S COATS IN THE WINTER AND SCHOOL SUPPLIES IN THE FALL ALONG WITH FEMININE HYGIENE PRODUCTS THAT ARE NOT COVERED BY THE SUPPLEMENTAL FOOD ASSISTANCE PROGRAM.
